**EAST HAVEN DRIVE SEWER AND WATER IMPROVEMENTS - ELEANOR AVENUE TO EAST  
FOOTHILL DRIVE  
CIP Project Number: C01684**

Dear Residents:

The City of Santa Rosa is contracting with Argonaut Constructors for construction of the above referenced project. Construction will begin in October 2023 and weather dependent, last through April 2024. Residential lane closures will be restricted to the hours between 8:30 a.m. and 4:00 p.m on Monday through Friday. This project will replace the existing aged sewer and water mains with 8" sewer and 8" water main in Eleanor Ave, in East Haven Dr from Eleanor Ave to East Foothill Dr, and in East Foothill Dr from Thomas Dr to Siesta Ln (see reverse for Project Limits).

Completion of this project is vital to the integrity of our community infrastructure. Some of the benefits this project will bring to your neighborhood include:

- Upgraded pipe materials to help improve the sewer and water system's performance.
- New sewer lines to (1) reduce the potential for blockages due to tree root intrusion and significantly reduce the need for repairs, and (2) reduce groundwater infiltration into the sewer system, which helps maintain the effectiveness of our Wastewater Treatment Plant.
- New water lines to help protect your home and property by improving water flows and pressure to fire hydrants.
- New reconstructed roadway to improve roadway smoothness and decrease road noise.

Though temporary impacts to your neighborhood are inevitable, our goal is to improve our community infrastructure without creating any more disturbance than necessary. If residents will need to park cars outside of the work zone, you will receive 72 hour notification prior of such action. The Contractor will be advised that daily and weekly activities such as mail delivery and garbage service must continue during the project.
