GUERNEVILLE ROAD PEDESTRIAN PATH

Dear Residents:

The City of Santa Rosa is using internal construction crews for construction of the above referenced project. Construction will begin once revised easements and right of entries are acquired. The crew expects to take not more than a month to complete work in front of one property once work has started there; the entire project is anticipated to take eight (8) months to complete. The project will construct new sidewalks along the north side of Guerneville Road between Marlow Road and Ridley Avenue, except at 1665 Guerneville Road. As a result, the project will be adding one (1) new accessible pedestrian curb ramp, and a new bus stop pad. (see reverse for Project Limits).

Completion of this project is vital to the integrity of our community infrastructure. Some of the benefits this project will bring to your neighborhood include improved pedestrian access in the area and enhanced accessibility with Installation of Americans with Disability Act (ADA) compliant pedestrian curb ramp.

Please be careful exiting your driveway during construction. If your driveway is within the project limits, you will be notified in advance of reduced driveway width access. You will have a minimum of seven (7) feet wide access for vehicles at all times to at least one driveway to your property. Reduced driveway width is not expected to exceed one week at any one property. Please let me know at this time if there are any restrictions to reduced driveway width access overnight.

Though temporary impacts to your neighborhood are inevitable, our goal is to improve our community infrastructure without creating any more disturbance than necessary. The Contractor will be advised that daily and weekly activities such as mail delivery and garbage service must continue during the project. If you are aware of other occupants on your property who may not receive this notice, please share this notice with them or contact me with their address and I will notify them directly.
