LOWER COLGAN CREEK RESTORATION - PHASE 3

Dear Residents:

The City of Santa Rosa is contracting with Team Ghilotti, Inc. for construction of the above referenced project. Construction will begin approximately June 16, 2025, and last approximately 5 months.

This restoration project will greatly enhance native wildlife habitat, water quality, and stream shade while reducing flood risk and improving outdoor recreation opportunities. A multi-use pathway will be constructed along the northern and western side of the channel and a pedestrian bridge will connect the new pathway to Bellevue Avenue. Most of the trees lining Monument Drive and along Bellevue Avenue will remain. However, widening and re-contouring the channel will require the removal of 166 trees within the project limits. This project includes planting and maintaining approximately 437 native mitigation trees while maintaining another 207 trees, 760 shrubs, 1,190 flowering forbs, and 5,800 grasses to enhance the riparian habitat. Two acres will also be seeded with milkweed and other nectar flowers for monarch and pollinator habitat. (See reverse for project limits).

Though temporary impacts to your neighborhood are inevitable, our goal is to improve our community infrastructure without creating any more disturbance than necessary. The Contractor will be advised that daily and weekly activities such as mail delivery and garbage service must continue during the project.
