GEYSERS PIPELINE EXPANSION JOINTS REPLACEMENT

Dear Residents:

The City of Santa Rosa is contracting with Piazza Construction for construction of the above referenced project. The project will consist of replacing 5 expansion joints in the Geysers Pipeline between Bear Canyon and Mayacamas pump stations on Pine Flat Road. Construction will begin on April 19, 2021 and last approximately 8 weeks. (see reverse for Project Limits).

Completion of this project is vital to the integrity of our community infrastructure. It will ensure that treated wastewater the pipeline conveys will continue to allow clean power to be generated by Calpine in the Geysers geothermal region.

Though temporary impacts are inevitable, our goal is to improve our community infrastructure without creating any more disturbance than necessary. Pipeline maintenance activities can only be performed once a year during a 30-day shutdown window and in order to complete this work, it may be necessary at times for the contractor to work 24-hours a day, 7 days a week. During joint replacement and roadway rehabilitation short term roadway closures of up to 30 minutes at a time may be required. The Contractor will be advised that daily and weekly activities such as mail delivery and garbage service must continue during the project. 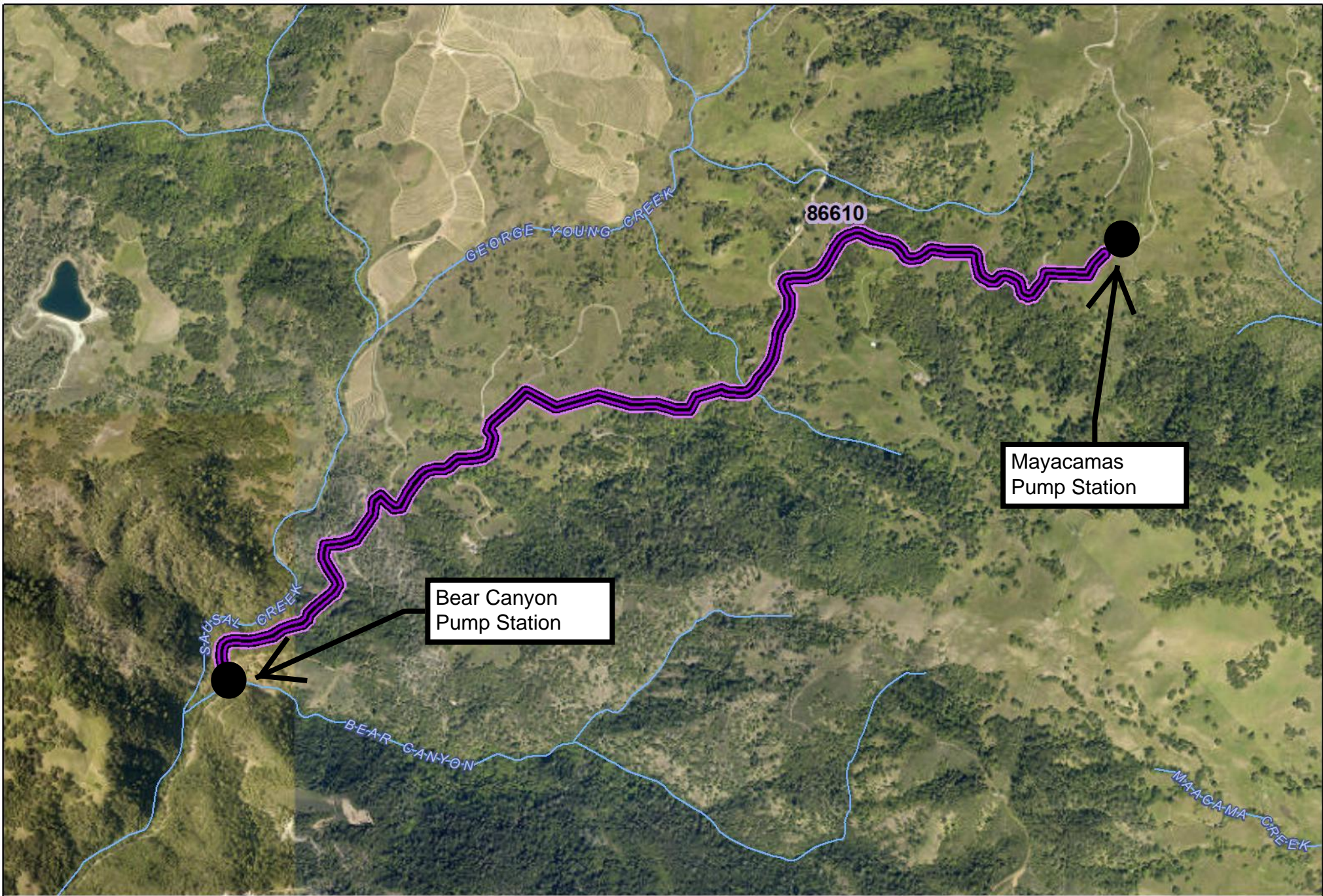

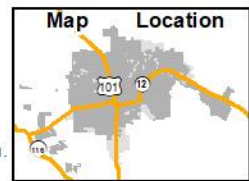
