## **GEYSERS PIPELINE EXPANSION JOINTS REPLACEMENT – PROJECT UPDATE**

Dear Residents:

The City of Santa Rosa has contracted with Piazza Construction for construction of the above-referenced project. The project will consist of replacing 5 expansion joints in the Geysers Pipeline between Bear Canyon and Mayacamas pump stations on Pine Flat Road. The letter from the City dated March 31, 2021 stated a Construction starting date of April 19, 2021, with construction lasting approximately 8 weeks.

Due to a delay in parts delivery, the Contractor will be at Bear Canyon Pump Station on Friday, May 14 and Saturday, May 15, 2021, to offload expansion joints from delivery trucks. They are then scheduled to begin installation of traffic control and the dewatering system during the week of May 17, 2021. Project excavation and installation including implementing traffic control is expected to begin Tuesday, June 1, 2021 and last approximately 8 weeks.

Though temporary impacts are inevitable, our goal is to improve our community infrastructure without creating any more disturbance than necessary. Pipeline maintenance activities can only be performed once a year during a 30-day shutdown window and in order to complete this work, it may be necessary at times for the contractor to work 24-hours a day, 7 days a week. During joint replacement and roadway rehabilitation, short term roadway closures of up to 30 minutes at a time may be required. The Contractor will be advised that daily and weekly activities such as mail delivery and garbage service must continue during the project. 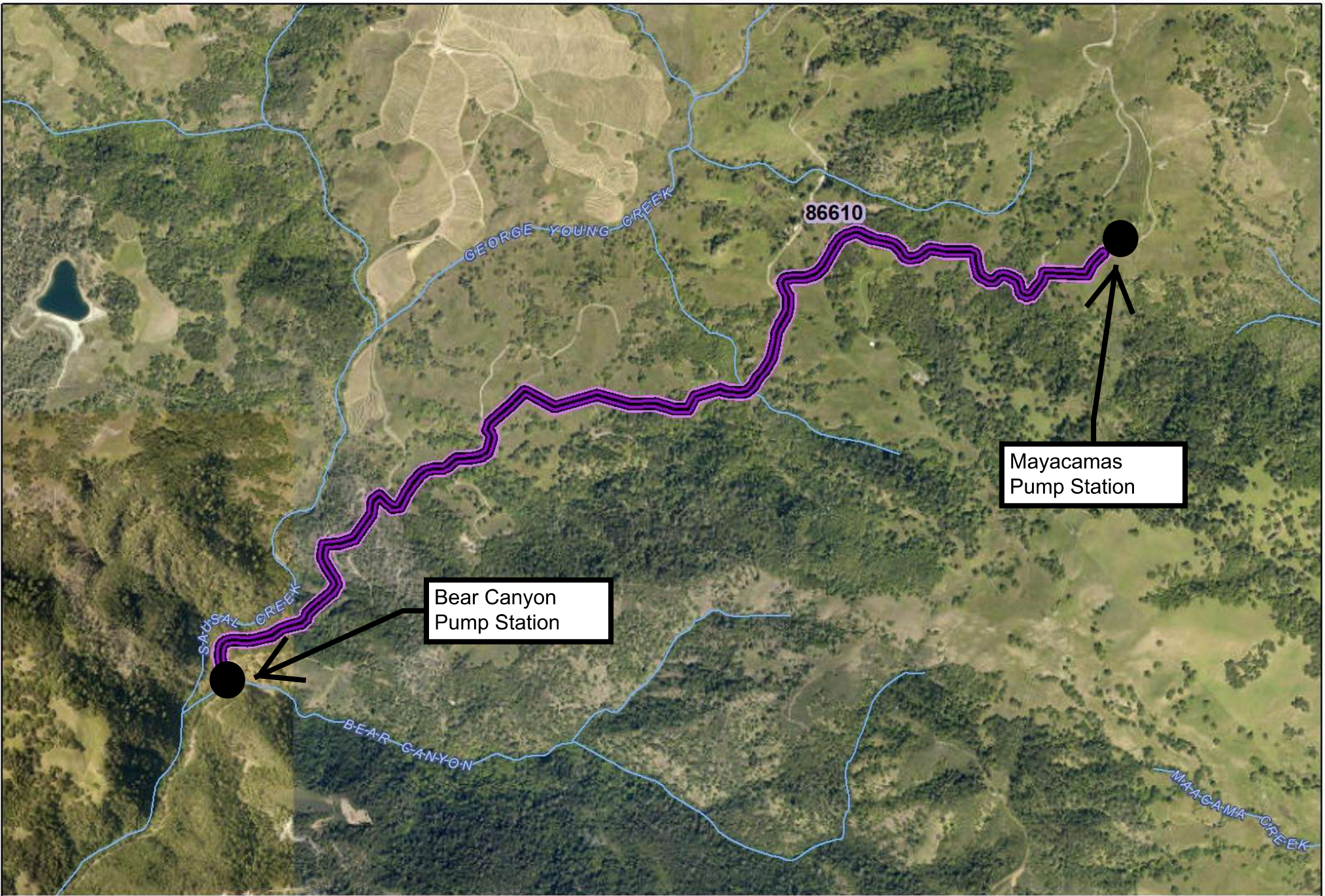
