**THE LLANO TRUNK REHABILITATION PHASE 1 PROJECT  
PROJECT ID NO. 02403**

Dear Residents:

The City of Santa Rosa is finalizing construction plans to complete the Llano Trunk Rehabilitation Phase 1 Project, which will improve a critical part of the City's wastewater system. The project will rehabilitate approximately 8,100 feet of 66-inch trunk sewer line and twelve manholes adjacent to Llano Road.

The project is expected to begin JUNE 15, 2025, and take approximately four months to complete (see attached map for project area). Completion of this project is vital to the integrity of our community infrastructure. Maintaining this trunk sewer line will minimize the risk of future failure and is therefore critical for the health and safety of neighboring properties.

To rehabilitate the trunk, crews will use a trenchless cured-in-place pipe (CIPP) lining technology. This approach minimizes surface disruption while reinforcing the existing pipe from within. During construction, a temporary above-ground sewage bypass pumping system will operate 24 hours a day, until all rehabilitation efforts are complete. This system will include full backup pumping capacity and three parallel 18-inch bypass lines running about 9,000 feet adjacent to Llano Road. Installation of these lines will involve work across several county roads and bridges.

At the north end of the project area, (see attached map), bypass pumps will be in operation and may produce some noise. However, noise-reducing measures will be in place to help minimize the impact. During the sewer lining installation, you may notice a chemical odor. This is caused by a small amount of airborne styrene, a key ingredient in the resin used for the liner. This odor is temporary and not harmful, and will quickly dissipate once the installation is complete.

Though temporary impacts to your neighborhood are inevitable, our goal is to improve our community infrastructure without creating any more disturbance than necessary. The Contractor will be advised that daily and weekly activities such as mail delivery and garbage service must continue during the project. Temporary lane closures are expected. Please stay alert for traffic changes and follow the instructions of flaggers at all times.
