HEARN AVE ABATEMENT AND DEMOLITION - 1004, 980, 976

Dear Residents:

The City of Santa Rosa is finalizing construction plans for the abatement of hazardous materials and demolition of existing structures located at 1004, 980, 976 Hearn Ave. The project is anticipated to take a total of 35 working days, with an estimated start date of February 16, 2024 (see reverse for Project Limits).

Completion of this project is vital to the integrity of our community infrastructure. Some of the benefits this project will bring to your neighborhood include:

- Visual reparations to existing features located at the noted parcels
- Site accommodations for future community development projects such as a Fire station, Library, and Multicultural/recreation center
- Accommodations for the future extension of Dutton Avenue

Though temporary impacts to your neighborhood are inevitable, our goal is to improve our community infrastructure without creating any more disturbance than necessary. The Contractor will be advised that daily and weekly activities such as mail delivery and garbage service must continue during the project.
